• Avoid sharing business data: when discussing sensitive data, it is best to use generic examples instead of sharing specific details. This helps maintain privacy while still receiving the output required.

 Keep devices secure: Ensure that the devices you use to access AI services are protected with strong passwords, updated security software, and encrypted connections.






